1. Meeting called to order

12. General Business

The following information was presented to the meeting for the information of members of the District.

Disposal of Redundant ABN for District 69 Toastmasters International (Unincorporated Entity) Update

History

In July 2022, Westpac Bank advised the District that it was not operating in accordance with the revised Banking Regulations (resulting from the Banking Royal Commission).

Consequently, Westpac advised the District that it needed to create a new ABN as an "Unincorporated entity".

After much hassle, this was achieved resulting in the District having two ABNs. We thank Don Crombie DTM for all his efforts to achieve this.

We have now received written advice (from Westpac KYC section) that our original ABN as an "Other Incorporated entity" was satisfactory.

At the same time, Toastmasters International engaged an Australian Tax Consultant and Lawyer to examine issues associated with possible changes to the status of "Not for Profit" organisations with respect to GST.

The District 69 Trio has been liaising with Toastmasters International regarding both these issues, but as yet, we do not have an answer, with which we are comfortable.

The District Trio will continue liaising with TI until we receive a clear understanding of the implications of all the changes.

District Conference 2026

An expression of interest to host the District Conference 2026 was received from Western Division. There being no further nominations, we congratulate Western Division, as our 2026 Conference Hosts.

District October-November event

In previous years, District 69 used to hold a Semi – Annual meeting for educational and networking purposes. This practice was discontinued on the advice of Toastmasters International.

However, at the recent Toastmasters International Board of Directors meeting, the Board advised that Districts may elect to hold an additional event in October-November.

The District Executive is seeking guidance from the members as to whether such an event would be beneficial (if held).

No other General Business matters were submitted in writing to the District Council for consideration.

13. Date of next meeting

The next meeting of the District Council will be in September 2025.

14. Closure of Meeting

Members of the District Council are encouraged to submit motions on notice or requests for discussion to the District Administration Manager.

Submission in advance allows for an informed conversation and allows members of the DCM to represent the views of their members and gain an understanding of the topics under consideration.
