7. Motions on Notice

Motion 1 – Approving the District 69 2026-27 Budget

Preamble:

Toastmasters International has advised that the anticipated income for District 69 for 2026-27 will be \$140,506.49. The District Trio in conjunction with the District Finance Manager have divided the allocation into the various budget categories as approved by Toastmasters International. The draft 2026-27 District Budget has been posted on the District 69 website.

Motion 4 – Remote Leadership

This motion will enable the District Council to provide firm guidance to the District Leadership committee on whether remote leaders will be able to serve in the 2027-2028 Toastmasters year in D69. From the Governing Documents:

1. Fully Remote District Leader: Any District Executive Committee member having a registered domicile outside the boundaries of the District in which they are serving and who will not attend onsite events as required by the District.
2. Partially Remote District Leader: Any District Executive Committee member having a registered domicile outside the boundaries of the District in which they are serving but who will attend onsite events as required by the District.

Motion 4:

THAT the District Executive recommend to Council that from 2027-2028 District 69 permits both local and partially remote but not fully remote elected District Leaders.

Motion 5 - Financial Considerations of Remote Leadership

This motion is conditioned on any form of remote leadership being approved.

Motion 5:

THAT the District Executive recommend to Council that the District should not reimburse costs for remote leaders in the 2027-2028 program year.
